  (AIRC) to provide strategic thinking, and promote and support the adoption of integrated thinking and IR in Africa
  - Adopting integrated thinking and IR will contribute to improving decision making, transparency and accountability especially as to how organizations in the public and private sector are creating value and contributing towards improving lives of citizens – ending poverty and boosting shared prosperity

#### 4. Regional Cooperation

- PAFA takes a multi-pronged approach to working with stakeholders at continental, regional and national levels
- PAFA has fully embraced the African Union Agenda 2063. It has committed itself to working with all Pan African organisations towards the realisation of the aspirations of Agenda 2063



#### **Regional Cooperation**

 The African Union – PAFA has entered into an MOU with the AU in order to get a platform on which it can interact with Governments in Africa.

#### **Proposed Priority areas being:**

- $\checkmark$  Integrated Thinking and Reporting.
- ✓ Public Value Management.
- $\checkmark$  Developing the Accountancy Profession in Fragile States.
- $\checkmark$  Remodelling the Accountancy Profession in Francophone Africa.
- Harmonising Accountancy Training, Practice and Regulation in Africa.

#### **Regional Cooperation**

 Organisation for the Harmonisation of African Business Laws (OHADA) – This is an organisation that brings together 17 countries (mainly Francophone) in Africa. The organisation has the responsibility of making business laws for the 17 countries. PAFA has signed an MOU with OHADA which allows it to participate in various deliberations



#### **Regional Cooperation**

- African Organization of Public Accounts Committee
  (AFROPAC) Working towards signing an MoU that will:
  - ✓ Foster cooperation at country level between the Professional Accountancy Organisation and the Public Accounts Committee (PAC), to effectively assist members interrogate the Auditor General's report. This will potentially enhance accountability among accounting officers.

#### 5. Thought Leadership

- African Accounting & Finance Association (AAFA) call for research papers initiative which seeks to advance knowledge of accounting and/or financial practices in Africa and via appropriate dissemination, inform and influence policy and IT at national and continental levels.
  - ✓ The Initiative is open to research in emerging trends in accounting and finance practices aimed at advancing academic knowledge and professional practice of accountancy in Africa
