# Lifestyle & Audit



Lifestyle.....

- The sum total of who you are, habits, standards, attitudes, moral standing, economic level, work ethic, etc
- □ Audit is a systematic, objective, methodological review on a sample basis mostly of financial records with or in order to make an opinion as to whether those records support the financial statements and that they reflect and true and fair view of the results of a given period of trading

# Lifestyle Audit



A lifestyle audit is the term commonly used by forensic auditors and management in companies to describe the tests that are performed to determine if the lifestyle of an employee is commensurate with that person's known income stream. The employer has detailed knowledge of the remuneration which they pay to the employee, but often management will only have rudimentary knowledge of the staff member's lifestyle.

## 2<sup>nd</sup> Def



The lifestyle audit is simply an amalgamation of reports from a variety of databases, which provide management/government or investigators with a snapshot into certain aspects of the life of an employee/ public officer . Lifestyle audits are largely fraud/ corruption prevention and detection mechanisms.





Generally, it is the answer in response to people living beyond their means.

- □ Al Capone in the 1930s, a criminal gang, he murdered his way to wealth, convicted on the basis of un-explained wealth died while worth about 100 Million USDs in 1947
- □ 7 years in prison, but was able to pay all the fines and back taxes from the illicit wealth

#### In October 2015,

"after Kenya Revenue Authority failed to achieve its revenue target, an irritated Uhuru blamed it on corruption and tax evasion - he would then order a lifestyle audit on Treasury and Kenya Revenue Authority (KRA) staff"



#### April 20, 2016

The Kenya Revenue Authority has started a lifestyle audit on its staff beginning with the most vulnerable departments. The audit comes a time when KRA is 69 billion shillings behind its third quarter revenue target. According to KRA Director General FCPA John Njiraini, all its 5,000 workers will undergo the lifestyle audit.



#### June 2018

An angry President Kenyatta has ordered that all heads of procurement and accounting units be vetted again. He said the vetting would include subjecting the officers to polygraph tests to determine integrity.
