
#### Background














#### Background



- ☐ For counties the County Integrated Development Plan provide a critical foundation for accelerated, inclusive and sustainable development.
- ☐ The PFMA (2012) Sec 126 (1) establishes the need for counties to prepare integrated development plans
- □ County Government Act, 2012, stipulates that county government shall plan for the county and no public funds shall be appropriated outside a planning framework developed by the County Executive Committee and approved by the County Assembly.

#### Types of Plans



The County Government Act 2012 provides that counties should prepare the following plans:

- ☐ County Integrated Development Plans (CIDP)
- ☐ Annual Development Plans
- ☐ Sectoral Plans
- ☐ Spatial Plans

#### CIDP



- ☐ County Integrated Development Plans (CIDP) is a five year plan integrating all the other plans
- ☐ It should have:
- i. Clear goals and objectives
- ii. Implementation plan with clear outcomes
- iii. Clear reporting mechanisms
- iv. Measures of undertaking monitoring and evaluation

#### CIDP Cont'd



CI	DP should identify:
	Investment initiatives in the county
	Infrastructural developments e.g. roads
	Key performance initiatives for the county
	Projects, plans and programs to be implemented
	Institutional framework to implement the plan such
	as organizational structure
	Resource mobilization measures and management
	such as budgets, revenue raising measures, etc
	It should contain attachments such as statistics, maps
	and other relevant documents

# Annual Development Plans (ADP)



☐ They are prepared to aid in implementing the CIDP ☐ It takes into account the challenges experienced and the lessons learnt in the implementation of the previous plans (Both CIDP and ADP) ☐ It aims at establishing links between policy planning and budgeting to ensure attainment of the expected plans. ☐ It identifies key priorities of the county ☐ It should be developed through consultative forums ☐ It is prepared yearly

#### Sectoral Plans



- ☐ They are 10 year plans which are formulated as components of the CIDP
- ☐ They are reviewed every five years by the county executive with approval of the county assembly
- ☐ They can be updated annually
- ☐ They must be program based and form the basis for both budgeting and evaluation of performance

#### Spatial Plans



- ☐ It is a 10 year Geographic information system (GIS) based database
- ☐ It is a component of the CIDP
- ☐ It must contain the following details:
- i. A spatial details of social and economic development programs of the county contained in the CIDP
- ii. Statement of how the plan is linked to regional, national and other county plans
- iii. Sustainability of the spatial plan

#### Linkage of Plans




□ County Integrated Development Plans (CIDP) is the overarching plan for county governments, all the other plans must linked to the CIDP
 □ It supersedes all the other plans in counties
 □ The fiscal goals and targets identified in the CIDP are implemented through the other county plans
 □ The interrelationship is depicted in the following diagram

Key: Dev. = Development, Rec. = Recurrent MTEF = Medium Term Expenditure Framework

#### Public Participation



- As per Chapter 12 of the constitution "there shall be openness and accountability, including public participation in financial matters."
- □ Section 125(2) of the PFM Act 2012 provides that the CEC member for finance shall ensure that there is public participation in the budget process.
- ☐ Public participation is based on the constitutional foundation which places sovereign power on the people of Kenya

#### Public Participation Cont'd



The high court in Petition 532 of 2013 and several other consolidated petitions stated that "Public participation ought to be real and not illusory and ought not to be treated as a mere formality for the purposes of fulfilment of the Constitutional dictates. It is my view that it behoves the County Assemblies in enacting legislation to ensure that the spirit of public participation is attained both quantitatively and qualitatively......"

#### Public Participation Cont'd





### Budget Implementation Challenges



Funding challenges - delays and budget cuts
Lack of proper consultations resulting in resistance
Inaccurate estimation of revenues to be generated by
counties, resulting to stalled projects
Poor leadership - integrity/ethics
Institutional wars - fights between county
assemblies and county executive
Multiple National government guidelines/policies
Huge pending bills in counties
