### Value - Based Leadership



- ☐ This is **leading by staying true to one's values**
- ☐ To lead by remaining consistent to one's beliefs and never swaying from the fundamental values
- ☐ The leader may change his or her strategy, tactics, or approach given the situation, **BUT** the leader never changes his or her underlying values, beliefs, or principles

- ☐ Leadership: The ability to inspire others, establish trust, and promote teamwork

### Leading Self



☐ Great leadership is a cultivated art – it begins with self leadership

#### **Components of Self Leadership**

- **Self Awareness:** The ability to acknowledge , understand and be conscious of own values, perspectives, strengths, weaknesses, leadership propensity and emotional needs
- □ **Self Management:** The ability to nurture and harness ones own passion, abilities, emotions and leadership capacity in decision making

### Leading Self



- □ Other-Awareness: The ability to acknowledge and recognize the passion, gifting, strengths, weaknesses, potential and needs of others
- □ Other-Management: The ability to grow and motivate other people to develop their potential and/or fulfil the organization's objectives

- ☐ Increase in self awareness and authenticity
- ☐ Appreciating others even as you appreciate yourself
- ☐ Preventing derailment not to self-destruct
- ☐ Ensuring long term success focus on what's important

### 'Leading Self' Key Take - Aways




- Focus on developing character not personality

### Defining Corruption



- 1. The origin of the word is from the Latin corruptus (spoiled) and corrumpere (to ruin; to break into pieces).
- 2. The working definitions presently imply that it is "the misuse of a public or private position for direct or indirect personal gain".

### Corruption and Kenya



- In 2017, Kenya was ranked no. 143 out of 180 countries on Transparency International's corruption Perception Index.
- ❖ The only African countries that scored worse include; Somalia, South Sudan, Libya, Eritrea, Burundi, and Zimbabwe and these were either politically unstable or in conflict.

### Corruption and Kenya



- Corruption is a secret activity that is very difficult to detect in some countries.
- In some instances, when discovered, the monetary value of the transaction tends to be elusive.
- Corruption has been around for a very long time

### Types of Corruption




- Bribery

- Fraudulent payment for sub-standard or defective goods

## Effects of Corruption across Counties




- Discourages investments
- High public debt


