The Future of Management – MA Adaptation Dilemma



- Just 17 years ago, Kodak had 170,000 employees and sold 85% of all photo paper world wide
- Within just a few years, their business model disappeared, and they went bankrupt
- This will happen in a lot of industries faster than before and most people in those industries don't see it coming
- If you do not seek the future, it will sneak up on you and most likely destroy you
- You don't need to go through the valley of the shadow of death (Lose everything) to take change seriously (At personal level??)
- Dismount all aging, weak and sick horses and mount those that can win races
- Determine what will change and what will not
