### **Economic Restrictions**

- Parents/Sponsors purchasing power
- Cultural orientation of Schools as not-for-profit



Need to Break from the Past!

Educational Institutions should work for SURPLUSES( not PROFITS)

Revenues should SUSTAINABLY exceed Costs

These Surpluses will guarantee:

Better service delivery and fulfilment of MANDATE Accumulated Surpluses will help manage future RISKS
