


Pursuant to the above mandate, the Committee is in the process of considering the Tax Laws (Amendment) Bill, 2020 (soft copy of the Bill can be accessed from the parliamentary website at <http://www.parliament.go.ke/the-national-assembly/house-business/bills>)

The Bill seeks to amend various tax related Statutes namely the Income Tax Act (Cap. 470), the Value Added Tax Act, 2013 (No. 35 of 2013), the Excise Duty Act, 2015 (No. 23 of 2015), the Tax Procedures Act, 2015 (No. 29 of 2015), the Miscellaneous Fees and Levies Act, 2016 (No 29 of 2016) and the Kenya Revenue Authority Act, 1995 (No. 2 of 1995).

Pursuant to the provisions of Article 118(1) (b) of the Constitution, the Committee invites your comments on the said Bill. The comments should reach the Committee on or before **Monday, 6th April, 2020.**
