The Chairman called the meeting to order at 10.45 a.m.

AGM 1/2019 : Notice, Proxies and Quorum

The Chairman welcomed members to the 41st Annual General Meeting of the Institute. He introduced Council members and recognized the past Chairmen of the Institute, past Council members, FCPAs, Branch Officials, AWAK Chairman and KCAU officials who were present. He also introduced the CEO and Secretary to the Council, CPA Edwin Makori and commended the Secretariat for their good work.

The Secretary to the Council then read the Notice convening the meeting, presented a summary of the proxies received, and confirmed that in accordance with Section 7(1) of the first schedule of the Accountants Act No. 15, 2008 and By-Law-43, the meeting was quorate.

The Chairman thereupon declared the meeting properly convened and constituted.

AGM 2/2019 : Apologies

Apologies which had been received were noted.

AGM 3/2019 : Adoption of the Agenda

The Chairman noted that the Notice and Agenda of the 41st Annual General Meeting was circulated through the e-connect. The same was also posted on the Institute's website.

It was resolved to adopt the agenda as circulated. This was proposed by CPA Erastus Kwaka (M/No. 2417) and seconded by CPA Georgina Malombe (M/No. 5138)

AGM 4/2019 : Minutes of the 40th Annual General Meeting

The Minutes of the 40th Annual General Meeting held on 7th June 2018 having been circulated to members prior to the meeting were taken as read.

It was resolved to approve the minutes of the 40th Annual General Meeting held on 7th June 2018 as proposed by CPA James Odero (M/No. 10812) and seconded by CPA Philip Kakai (M/No. 3767).

AGM 5/2019 : Matter Arising from the Minutes of the 40th Annual General Meeting

CPA Bernard Amukah had written to the Institute requesting for the following to be included as any other business in the 40th Annual General Meeting held on 7th June 2018;

1. "To table a motion introducing amendment of the Institute's constitution to permit election of both Chairman and Vice Chairman by members. Any member desiring the position of chairman shall pick his/her running mate. If approved, members shall elect a chairman with his Vice Chair at the ballot. A sitting council member desiring to become a chair will be free to pick from his/her colleagues any member who meets the qualifications for that role. Elected Chairman and his Deputy shall serve for one term and will be eligible for re-election but shall serve for a period not exceeding two terms. All members shall have equal chance of pairing and competing for the duo position. To propose revision of the term of Chairman and his/her deputy from the current two years to three years."
2. Members were informed that the Council was reviewing the proposal, and was pursuing other legislative changes to the governing structures of the Institute. Public participation would be sought, and other stakeholders including the National Treasury would be involved.

AGM 6/2019 : Council Report for year 2018

The Chairman presented the Council Report and noted that the Institute was now 41 years. He thanked members of the Council for the support in ensuring that the Vision, Mission and the Core Values of the Institute were upheld. He urged all members to abide by the Code of Ethics and to uphold professional standards.

The Chairman provided an update of the activities undertaken by the Council and the Institute over the past year. The salient highlights under the four pillars of the Strategic Plan (2016-2018) were noted as follows:

a) Customer Focus

- Active membership grew from 19,153 in 2017 to 20,610 in 2018
- Implementation of CRM systems to monitor customer responses by the Secretariat
- Success on Know You Customer (KYM) through data update by members
- The Institute inaugurated ICPAK brand ambassadors
- CPD events increased from 149 in 2017 to 185 in 2018. There was diversity of the events to serve the diverse

- membership, provide impactful workshop at affordable rates and serve members in branches
- In collaboration with KASNEB, the Institute rolled out the program on Trainee Accountant Practical Experience Framework (TAPEF) by visiting various accounting training institutions across the Country to enlighten and recruit trainee Accountants. Various Institutions initiated an internship program for trainee accountants to support this initiative
- Digital platforms:
 - o **ICPAK Live** - This had given the membership a space to interact with the Institute conveniently through their phones .
 - o **Online platforms** - The Institute had made it easy for members to file their CPD online, check their good standing status, undertake status update, print events certificates, access publications and have their concerns addressed on real-time basis.
 - o **Online CPD events** - Online CPD trainings had afforded members a convenient training platform at the comfort of their desks.
 - o **Live streaming** - All the major events were streamed live to allow members to follow the proceedings of such events wherever they were around the globe.
 - o **Online Voting** - This provided members convenience to vote from any corner of the globe.
- The Benevolent Scheme was approved during the 2016 Annual General Meeting and rolled out in 2017 to cater for the last expense benefit, with an intention to eventually cater for more benevolent benefits to members. During the year, 11 principle members, 10 spouses and 4 dependents benefitted from the scheme.

b) Regulating the Accounting Profession

- **Accountants Act** - Amendments to the Accountants Act were done through the Finance Bill of 2018. They included a new definition of the Accountant, insulation of Accountants in practice and improved penalties for noncompliance
- **Member registration** - The Registration and Quality Assurance Committee reviewed and admitted 2,891 new members and issued 79 practicing certificates
- **Quality Assurance** - The audit quality reviews and compliance checks grew by 20% to 200 firms in 2018.
- **Promotion of Professional Standards and Practice** - The Institute participated in Standard setting process by monitoring and commenting on all relevant exposure drafts papers (6) issued by IFAC Standard Setting Boards (SSB)
- The Institute provided technical assistance and training on IFRS 9 to financial sector entities.
- **FiRe Award** - The objective of the Award was to promote financial reporting excellence, foster sound corporate governance practices and enhance corporate social investment and social reporting. During the year 4 Promoters namely, ICPAK, CMA, NSE and PSASB continued to support the FiRe award. A growth of 10% was realized as 503 entities' participated in 2018 compared to 546 entries in 2017
- **Disciplinary** - New Disciplinary Committee members were gazetted by the Cabinet Secretary in July 2018.
- **Vetting Framework for IFAC and PAFA appointment** - The Institute continued to use the framework in the process of nominating members wishing to represent the Institute at IFAC and PAFA boards and committees.

c) Thought Leadership

- The Institute continued to position itself as an influential voice in public policy and decision making at the county, national and global level realized through; Stakeholders engagement and collaborations, Policy briefs, ICPAK representation at local, regional and global level, contribution towards legislative agenda, devolution agenda and contribution towards debates/events with Public Interest
- The Institute continued with Stakeholder engagements and collaborations initiatives:-
 - o **MoU** - The Institute signed an MOU with Safaricom and PSASB during the year
 - o **Parliamentary Initiative Network (PIN)** - The Institute drafted and implemented the guideline on “ how to read and analyze Finance Bills”
 - o **KRA-In** partnership with KRA, the Institute organized a series of stakeholder engagements to develop and finalize the Income Tax Policy
 - o **National Treasury**-The Institute continued to play a significant role in the budget making process through significant submissions and proposals to the National Treasury Budgetary Committee.

- o **Auditor Generals' Office (AOG)**- Held consultative meetings with AOG
 - o **Council of Governors (COG)** - Held a meeting with COG that deliberated on how the Institute can contribute towards county budget process
 - o **National Assembly** - Engagement culminated to amendment of the Accountant Act.
- The Institute continued to play a leading role in shaping the growth of accountancy profession at global level
 - Legislative affairs - The Institute reviewed and made proposals on legislations that had an impact on the accountancy profession and the economy at large
 - Legislative affairs - The Institute continued to engage and contribute toward various legislative bills

d) Institutional Sustainability

In order to grow and secure the future of the Institute, the Council and Management had given priority to the following:

- Strengthening the Institute's governance structures
- Healthy and motivated human capital
- Improved service delivery to members
- Revenue diversification to achieve financial sustainability
- Processes re-engineering and mainstreaming ICT operations
- Risk management and environmental sustainability

Looking Forward

The Institute was excited by the continued trajectory growth that it had taken. The Institute looked forward to the following in the coming years;

- Increased growth in membership and participation of the Institute's CPD events more so online CPD events.
- Diversification of revenue stream to sustain service delivery to the members
- Better customer services delivery supported by the new CRM system and feedback mechanisms established in the Institute
- Implementation of the provisions of the revised Accountants Act to improve the regulatory environment at the Institute
- Improved tenancy uptake at the CPA Centre building
- Increased stakeholders engagement
- Enhanced regulatory environment of the Accountancy Profession through increased collaborations and enhanced practice monitoring
- Undertaking of research based thought leadership on matters of governance and policy making

Other Key Highlights

- Need to relook at Member Protection Mechanisms
- Ensure a comprehensive Remuneration Order/Fair Pay is gazetted for the members

AGM 7/2019 : Financial Statements for the Year Ended 31st December 2018

CPA Victor Majani representing Messrs. Parker Randal East Africa, the Institute's Auditors presented the Auditors Opinion and noted that the Financial Statements gave a true and fair representation of the Institute's accounts in accordance with the International Financial Reporting Standards.

CPA Obare Nyaega, the Convener of Finance and Strategy Committee then presented a detailed analysis of the audited Financial Statements for the year ended 31st December 2018.

It was noted that;

- Revenue growth was impacted by rental income as occupancy at CPA Centre was not at full capacity
- Subscription Income-Increase in active members 19,153 in 2017 to 20,610 in 2018. However, during the year members transferred to inactive category was 1,587 compared to 1,135 in 2017
- Training Income-Increased number of CPD events, introduction of targeted trainings and heavy profiling of events increased seminars' participation
- The costs of CPD training increase was relative to the increased number of event participants due to general increase of prices for goods and services
- The variance in operating expenses was largely influenced by increased stakeholder engagement activities during the year for increased visibility of the profession.
- The Institute was granted Kshs 12.3 million by Business Advocacy Fund (BAF) to steer the development of Income Tax Policy. The Institute utilized Kshs 6.8 million during the year
- The Institute secured a facility of Kshs 425 million with Standard Chartered Bank Limited to part-finance the CPA Centre Building construction. During the year ended 31st December 2018, the Institute drew down a loan

amount of Kshs 100.5 million and repaid principal amounts of Kshs 55.8 million. This brought the loan balance to Kshs 488.9 million. Mortgage interest changed from 14% in 2017 to 13% in 2018

Thereafter, members were invited to discuss the Financial Statements. Members raised various issues which were responded to satisfactorily. Members were assured that the suggestions and proposals made would be looked into and acted upon.

It was resolved that the Financial Statements for the year ended 31 December 2018 together with the Council's and Auditors' Reports thereon be adopted. This was proposed by CPA Charles Musyoka (M/No. 33669) and seconded by CPA Robert Nyambane (M/No. 3889).

KCAU Financial Statements for the year ended 31 December 2018

CPA Evelyn Muriuki, the Convener of KCAU Finance Committee presented a detailed analysis and review of the Financial Statements for the year ended 31 December 2018.

It was noted that;

- Demand for University education in Private Universities continued to grow
- Public Universities were not able to meet expectations and demand
- The government was now putting more emphasis on TVET in general and STEM at the University level
- Total comprehensive income for 2018 was at Kshs 84,133,000/- compared to a loss of Kshs 80,888,000/- in 2017

AGM 8/2019 Appointment of Auditors for year ending 31st December 2019

The Council recommended to the members the appointment of Messrs Parker Randall East Africa as the Institute's external Auditors for the year ending 31 December 2019.

It was resolved to appoint Messrs Parker Randall East Africa as the Institute's Auditors for the year ending 31st December 2019 and to authorize the Council to fix their remuneration. This was proposed by CPA Ciugu (M/No 1980) and seconded by CPA Anthony Opondo (M/No. 11988).

AGM 9/2019 Election of Council Members

The Chairman invited CPA Isaac Ruto (M/No. 5893) who served as the Returning officer for the 2019 Council Elections to present the report on the results of the Elections.

The Returning Officer reported that there was a vacancy for the ICPAK Chairman position and three vacancies for ICPAK Council Member positions. The Institute declared the vacancies on 18th February 2019. As at 7th March 2019, the Institute had received 18 nomination forms from interested members. Two nomination forms were for the position of Chairman while 16 were for the position of Council Member.

Communication was made to the candidates on 27th of March 2019 on their nomination to vie for year 2019 Council Elections.

The Returning Officer declared CPA Rose Wairimu Mwaura, MBS as the duly elected Chairman of the Institute for a term of two years with effect from 7th June 2019.

The Returning Officer further declared FCCA Obiria George Moku, CPA Elizabeth Nthambi Kalunda and CPA Olick Risper Awuor as the duly elected Council Members of the Institute for a term of three years with effect from 7th June 2019.

It was unanimously resolved to confirm the election of CPA Rose Wairimu Mwaura as the Chairman of the Institute for a term of two years with effect from 7th June 2019.

It was further unanimously resolved to confirm the election of FCCA Obiria George Moku, CPA Elizabeth Nthambi Kalunda and CPA Olick Risper Awuor as Council Members of the Institute for a term of three years with effect from 7th June 2019.

FCCA Obiria George Moku, CPA Elizabeth Nthambi Kalunda and CPA Olick Risper Awuor were invited to join the Council. They thanked members for voting for them, and assured them that they would follow through with pledges made during the campaigns.

The Chairman thanked CPA Obare Nyaega, outgoing Council Member for his support and contribution to the Council, and dedication to the Institute for the 6 years he served in the Council.

The Chairman also thanked CPA Denish Osodo, the outgoing Vice Chairman for his valuable contribution to the Council and the Institute for the 2 years served in the Council.

CPA Denish Osodo thanked Council members for the support accorded to him during his tenure in the Council. He wished the Council, the Institute and the incoming Chairman the best of luck.

CPA Obare Nyaega, appreciated the support of Council members during his term in the Council. He wished the Institute and the incoming Council the best of luck.

Handing over of the Chairman's Chain

The outgoing Chairman, FCPA Julius Mwatu handed the Chairman's Chain to the incoming Chairman, CPA Rose Mwaura, MBS. He was assisted by FCPA Rose Ogega, a past Chairman of the Institute.

The Chairman thanked all Council members for their commitment to the Institute and to improving the accountancy profession. The Chairman appreciated the members for their support in the last two years he served as the Chairman of the Institute. He wished the incoming Council and Chairman the best of luck, and asked them to actualize their campaign pledges.

He stated that he would send members an Accountability Statement highlighting the achievements and gains made during his tenure as the Chairman.

CPA Rose Mwaura, MBS thanked all members for electing her, and for their support and trust in her. She pledged to work together with the Council, members of the Institute, and other stakeholders to improve the accountancy profession.

AGM 10/2019 : Any Other Business

It was reported that CPA George Guda Ouma (M/No14376) had written to the Institute requesting for the following to be included as any other business in the Annual General Meeting;

1. The reduction of hefty ICPAK compliance charges
2. Inclusion of the requirements of Chapter six of the Constitution as part of ICPAK election by-laws
3. Amendment of section 9 and 11 of ICPAK policy governing elections of Chairman and members of the Council
 - i) THAT the decision of the Council to increase compliance charges (seminars, workshops and trainings) for the purposes of compliance with the requisite CPD hours without member's consultation and or participation, be reversed, rendered null and void for being unconstitutional.
 - ii) THAT the Annual General Meeting considers the repeal and or amendment of article 4 -76 of ICPAK by-laws on election procedures, which omits the requirements of Chapter six of the Constitution.
 - iii) THAT section 9 and 11 of ICPAK policy governing elections of chairman and members of the council that grants the CEO and Election Scrutineers log in and system control rights be reversed, rendered null and void for contravening general principles for any sound electoral system as envisaged by the constitution and amended to comply with Article 81 (e) of the Constitution.

WHICH MOTION was premised upon the following grounds;

1. THAT the Institute may from time to time, by resolution passed by a majority of not less than two-thirds of the members present and voting (in person or by proxy) at a meeting specifically convened for the purpose with at least fourteen days-notice in writing, make such by-laws regulating the affairs of the Institute as it deems fit and from time to time rescind or vary any such by-laws and make others in their stead but so that the by-laws shall not in any respect be inconsistent with the express or implied provisions of the Act.
2. THAT Article 2(4) of the constitution of Kenya 2010 expressly ordains the constitution as the supreme law and that any law which is inconsistent with its provisions is void to the extent of such inconsistency and that any act or omission in contravention of the constitution is invalid.
3. THAT Article 1 of the constitution of Kenya 2010 grants the supreme authority to the people of Kenya as the ultimate law-givers and that further, article 2 decrees that any exercise of such authority by any occupier of a state or public office must be subject to the authorization of the constitution.
4. THAT further Article 10 of the constitution outlines the principles of good governance which ought to bind all state organs, state officers and public officers; such principles includes but not limited to democracy and participation of

the people.

5. THAT Chapter 6 of the Constitution lays down the standard criteria of integrity which must be complied with by all persons excising public authority.
6. THAT article 81(e) of the constitution decrees that any sound electoral system shall comply with the following principles: free and fair elections, which are; by secret ballot, free from violence, intimidation, improper influence or corruption, conducted by an independent body, transparent and administered in an impartial, neutral, efficient, accurate and accountable manner.

The CEO and Secretary to Council informed members that the matter would be taken up by the Council for deliberation. A report on the matter would be presented to the members at the 2020 Annual General Meeting.

THERE BEING NO OTHER BUSINESS TO TRANSACT, THE CHAIRMAN DECLARED THE MEETING CLOSED AT 4.00 P.M. AND INVITED ALL MEMBERS FOR LUNCH.
