The Chairman called the meeting to order at 10.25 a.m.

AGM 1/2021 NOTICE, PROXIES AND QUORUM

The Chairman welcomed members to the 43rd Annual General Meeting of the Institute. She noted that members were attending the meeting physically and virtually in compliance with the guidelines put in place by the government due to Covid-19 pandemic.

She introduced the Council members, and recognized past Chairmen of the Institute, past Council members, FCPAs, Branch Officials and KCAU officials who were present physically and virtually. She also introduced the CEO and Secretary to the Council, CPA Edwin Makori.

The Secretary to the Council then read the Notice convening the meeting and confirmed that in accordance with Paragraph 7(1) of the First Schedule of the Accountants Act and By-Law-43, the meeting was quorate.

The Chairman thereupon declared the meeting properly convened and constituted.

The Chairman asked members to stand for a minute of silence in respect of the members who had passed on in the last one year.

AGM 2/2021 ADOPTION OF THE AGENDA

The Chairman noted that the Notice and Agenda of the 43rd Annual General Meeting was published in the Daily Nation and circulated through the *e-connect*. The same was also posted on the Institute's website. She proposed that agenda Nos. 5 and 6 be varied to read as follows;

- Agenda No. 5- To consider and approve Council to appoint the Independent Auditor of the Institute for the financial year ending 31st December 2021, and to authorize the Council to fix the remuneration of the Auditor.
- Agenda No. 6- To present the elected Chairman of the Institute in accordance with Section 7 and Paragraph 1 of the First Schedule of the Accountants Act, and elected Council members in accordance with Paragraph 1 of the Second Schedule of the Accountants Act, and the Institute's Election Regulations.

Proposed by FCPA Abdul Wahid Aboo (M/No. 528) and seconded by CPA Bernard Ngondo (M/No. 4276), it was resolved to adopt the agenda as varied.

AGM 3/2021 MINUTES OF THE 42ND ANNUAL GENERAL MEETING

Minutes of the 42nd Annual General Meeting held on 12th June 2020 having been circulated to members prior to the meeting were taken as read.

AGM 5/2021

COUNCIL REPORT FOR YEAR 2020

The Chairman presented the Council Report and noted that the Institute developed and promulgated a Strategic Plan 2019-2021 in 2019. The Chairman noted that Covid-19 pandemic had an impact on the key assumptions of 2019-2021 Strategic Plan. Whereas the pandemic was a health crisis, its economic ramifications were even greater. This prompted the Institute to scan its new environment with an intention to develop and engage proactively in new activities that would guarantee its sustainability.

The Institute I had to re-examine it's strategy afresh and developed a short-term Strategic Plan to December 2020 which had three Pillars, eleven Strategic Objectives and twenty three Sub-Strategic Objectives. Going forward, the Institute will develop short term strategic plans of an year to adopt to the pandemic and its impact until when a new normal will have been established.

The Chairman provided an update of the activities undertaken by the Council and the Institute over the past year, and the salient highlights under the three Pillars of the Strategic Plan as follows:

a) Pillar 1 - Institutional Sustainability

Council and Management identified the following key areas to guarantee sustainability of the Institute during the Covid-19 pandemic;

- Innovatively offer virtual events and members' engagements
- Adoption and implementation of ICT in all Institute's operations
- Enhanced regulation focusing on virtual support to Practitioners
- Cost optimization through processes engineering

a) Pillar 2 - Accountancy Development and Regulation

- Active membership growth from 21,691 in 2019 to 22,908 in 2020
- In collaboration with KASNEB, the Institute continued the roll out of the Trainee Accountant Practical Experience Framework (TAPEF) program through recruitment of mentors and trainee accountants. Enrolled 280 new trainees to a total of 531, and 110 new supervisors to a total of 588
- As mandated by the Accountants Act to advise the examination board on curriculum, the Institute spearheaded a major review of the CPA qualification syllabus
- The Institute developed and approved the multiple license framework
- The Institute invoked the mandatory training policy for Practitioners. This contributed to the growth in numbers of members who were CPD compliant

- The FiRe Award was not held in year 2020 due to Covid-19 pandemic. A total of 286 entities participated by submitting entries for evaluation which was a significant decrease from 687 participating entities in the previous year, largely due to the effects of the pandemic
 - FiRe Award received a special recognition by the United Nations Conference on Trade and Development (UNCTAD) for its contribution towards sustainability and promotion of sustainable business practices through quality financial reporting
 - The Institute participated in the Standard setting process by monitoring and commenting on Discussion Papers, Exposure Drafts and Standards issued by IFAC- ISSB
 - The Institute continued to provide technical assistance and trainings on International Standards as issued by IFAC
 - The Institute issued reporting templates and technical guidelines to members
 - The Institute engaged CBK, IRA, SASRA, CMA, KBA among other stakeholders in the adoption of the accounting and auditing standards
 - At the Chairman’s Ball held on 11th December 2020, the Institute awarded the Commendation award to forty-three members, and Fellowship to fifteen members
- a) Pillar 3 - Positioning and Customer Focus
- The Institute continued to position itself as an influential voice in public policy and decision making at the county, national and international levels through stakeholders engagements and collaborations, policy briefs, representations, contribution towards legislative agenda, devolution agenda, engagements in public discourses, among others
 - Engaged with Parliament leadership through the Office of Majority Leader and made written and verbal presentations before the National Assembly Departmental Committee on Finance and Planning, and Senate Finance Committee on various legislative proposals
 - The Institute constantly reviewed and made proposals on various legislations that have an impact on the accountancy profession and the economy at large
 - The Institute in collaboration with Kenya School of Government and KASNEB organized a successful Inaugural Research conference held in December 2020
 - Due to Covid-19 pandemic, Branches had few physical activities. However, each of the nine Branches conducted CSR activities in their Branches
 - The Institute continues to play a leading role in shaping the growth of accountancy profession at global level. Thus, the Institute is well represented in IFAC and PAFA
 - The Institute signed an MOU with Amnesty International on collaborations to establish and explore a framework for implementing jointly, activities that promote and protect professional ethics, integrity, and human rights
 - The Institute recorded an overall member satisfaction level of 68% out of a 75%

satisfaction index target, up from 63% in the previous year. Though the Institute performed well, there was still room for improvement going forward

- The Institute established a dedicated customer service desk comprising of four staff for effective response to members
- Systems were enhanced to provide timely update of CPD hours for members through automation of CPD self-declaration upon attendance of ICPAK and other events
- The Institute fully implemented its Call Centre system that allowed it to track and monitor its incoming calls response. The system had seen call management improve and maintained at 90% response rates

Numbers and Demographics

- In year 2020 despite the decline in total revenue, the Institute achieved a surplus of Kshs 99.6 million; 312% growth from the previous year
- The continued growth in surplus was attributed to the good stewardship, well-defined team structure, and consistent membership growth, diversification of revenue and thrift financial management. This enabled the Institute to continue implementing financial strategies despite the Covid-19 pandemic
- Initiated and advanced the development of the Accountants Act Regulations, 2021
- Paid Kshs 128 million of CPA Centre loan at the beginning of year 2021, and the balance was Kshs 250 million
- Lobbied and received 300 Covid-19 vaccines from the Ministry of Health for staff and members of the Institute

Looking Forward

Notwithstanding challenges posed by Covid-19, the Institute looks forward to a brighter future as follows;

- Implement the multiple licenses
- Establishment and implementation of Whistle Blowing for members
- Enhanced member protection to advance credibility and accountability
- Gazetttement and implementation of Regulations to the Accountant's Act
- Review the business model of the Institute in line with the new normal due to Covid-19
- Increased growth in membership and increased participation of the Institute's CPD events more so virtual CPD events
- Diversification of revenue streams to sustain the service delivery to the members
- Better customer service delivery supported by the new CRM system and feedback mechanisms established in the Institute

- Implementation of the provisions of the revised Accountants Act to improve the regulatory environment at the Institute
 - Improved tenancy uptake at the CPA Centre building
 - Increased stakeholders engagement
 - Enhanced regulatory environment of the Accountancy profession through increased collaborations and enhanced practice monitoring.
 - Undertaking of research-based thought leadership on matters of governance and policy making

Report of the Ad Hoc Review Committee

The Chairman invited FCPA Stephen Lugalia who served as the Chairman of the ad hoc Review Committee to present the report of the Committee.

It was noted that the Committee was constituted by Council and approved by members at the 42nd Annual General Meeting held on 12th June 2020 to look into various petitions received from members during past Annual General Meetings.

FCPA Stephen Lugalia took members through the recommendations of the Committee which were on the following;

- Title of the Chairman and Vice Chairman of Council
 - Nomination of the President, Vice President and Members of Council
 - Tenure of President, Vice President and Members of Council
 - Composition and eligibility criteria for members of Council
 - Filing of casual vacancies in Council
 - How to cure flashy, polarized and hyped election campaigns/Management of elections
 - Transitional Provisions with regard to the proposed amendments
 - Establishment and operation of the College of Fellows

The report would be circulated to members after the meeting for public participation, and comments to be submitted to the Institute by 25th June 2021.

Proposed by CPA Wallace Kimani (M/No. 13061) and seconded by CPA Dickson Njiru (M/No. 9330), it was resolved to adopt the Council Report for the year 2020.

AGM 6/2021 FINANCIAL STATEMENTS FOR THE YEAR ENDED 31ST DECEMBER 2020

CPA Victor Majani representing Messrs. Parker Randal East Africa, the Institute's Auditors, presented the Auditors Opinion and noted that the Financial Statements gave a true and fair representation of the Institute's accounts in accordance with the International Financial Reporting Standards.

FCPA Samuel Okello, Convenor of Finance and Strategy Committee then presented a detailed analysis of the Financial Statements for the year ended 31st December 2020.

It was noted that;

- Significant growth in assets between the years 2011-2020 had been realized as a result of the CPA Centre building construction
- Revenue reduction was due to Covid-19 pandemic that led to restricted physical events. However, through innovation the Institute developed and rolled out virtual events
- Income Performance
 - Subscription Income-increased due to increase in number of active members from 21,691(2019) to 22,908(2020). However during the year, 1,551 members transferred to inactive category compared 1,355 members in 2019
 - Training Income-reduced due to impact of Covid-19 pandemic. The Institute rolled out virtual training that sustained the Institute during this period
- Increased member training costs-the costs of CPD training increased in line with reduced physical events resulting from Ministry of Health protocols during the pandemic
- Decrease in operating expenses-the variance was largely influenced by decreased activities at CPA Centre, and due to the working from home policy that was adopted after the 1st wave of Covid-19 in the country
- As part of sustainability measures during the pandemic, staff salaries, Council and Committee allowances were reduced by 50%. This also contributed to the reduction of operating costs in 2020
- Total assets increased marginally due to computer and intangible assets bought during the year. No fair value gain was registered on investment property (CPA Centre Building) while increase on Non-Current liabilities was due to unpaid loan and interest after repayment of the moratorium
- Occupancy level at CPA Centre Building was at 48%
- Increase in Property and Equipment and Investment property- the increase was as a result of the purchase of computers and intangible assets during the year. There was no change on the investment property (CPA Centre Building)
- Other receivables- this was represented by VAT recoverable on the construction project (CPA Centre Building)
- The Institute secured a loan facility of Kshs 625 million from Standard Chartered Bank Kenya Limited to part-finance the CPA Centre Building construction. During the year ended 31st December 2020, the Institute repaid principal amounts of Kshs 21 million. However, as a cushion to the impact of Covid-19 pandemic, the Institute was granted a nine months moratorium to January 2021 on principal and interest repayment. The loan balance at year end was Kshs 434 million. Mortgage interest rate charged reduced to 12.5%.

Thereafter, members were invited to discuss the Financial Statements. Members raised various issues which were responded to satisfactorily.

Proposed by CPA Said Salimu (M/No. 21625) and seconded by CPA James Angawa (M/No. 3784), it was resolved that the Financial Statements for the year ended 31st December 2020 be adopted.

KCAU Financial Statements for the year ended 31 December 2020

CPA Michael Ingutia, the Chief Finance Officer of KCAU presented a review of the Financial Statements for the year ended 31st December 2020.

It was noted that;

- The university had been impacted by Covid-19 pandemic and learning was undertaken online
- Demand for university education in Private Universities continued to grow
- Members of the Institute were encouraged to take advantage of discount facilities available to them and their families
- The University had challenges with funding and would work towards making it sustainable

AGM 7/2021 APPOINTMENT OF AUDITORS FOR YEAR ENDING 31ST DECEMBER 2021

Proposed by CPA Juma Simuelo (M/No. 3627) and seconded by CPA Thomas Mwadeghu (M/No. 945), it was resolved to approve Council to appoint the Independent Auditor of the Institute for the financial year ending 31st December 2021, and to authorize the Council to fix the remuneration of the Auditor so appointed.

AGM 8/2021 ELECTION OF CHAIRMAN AND COUNCIL MEMBERS

The Chairman invited CPA Sophie Moturi who served as the Returning Officer for the year 2021 Council Elections to present the report on the results of the Elections.

The Returning Officer reported that in year 2021 there was a vacancy for the Chairman and three vacancies for Council Member position. The Institute on 19th February 2021 declared the vacancies that were falling vacant at the end of the Annual General Meeting for year 2021. Interested members were invited to submit their duly filled nomination papers by 4th March 2021.

The Returning Officer declared FCPA George Obiria Mokua as the duly elected Chairman of the Institute for a term of two years with effect from 4th June 2021.

The Returning Officer further declared FCPA Georgina Maria Malombe, CPA Anne Wangechi and FCPA Hesbon Omollo as the duly elected Council Members of the Institute for a term of three years with effect from 4th June 2021.

It was unanimously resolved to confirm the election of FCPA George Obiria Mokua as the Chairman of the Institute for a term of two years with effect from 4th June 2021.

It was further unanimously resolved to confirm the election of FCPA Georgina Maria Malombe, CPA Anne Wangeci and FCPA Hesbon Oyieko Omollo as Council Members of the Institute for a term of three years with effect from 4th June 2021.

FCPA Georgina Malombe, CPA Anne Wangeci and FCPA Hesbon Omollo were welcomed to the Council. They thanked members for voting for them, and assured them that they were committed to serve the Institute, and would follow through with pledges made during the campaigns, and be responsive to members' needs.

FCPA Samuel Okello, the outgoing Council member, thanked the Council for the support accorded to him during his tenure in the Council. He urged the Council to address issues affecting members in the public sector. He stated that he was available to continue serving the Council, the Institute and members, and wished the incoming Council the best of luck.

The Chairman thanked FCPA Samuel Okello for his valuable contribution and support to the Council, and his dedication to the Institute.

Handing over of the Chairman's Chain

The outgoing Chairman, FCPA Rose Mwaura, MBS handed the Chairman's Chain to the incoming Chairman, FCPA George Obiria Mokua.

FCPA Rose Mwaura, MBS thanked Council members for their commitment to the Institute and to improving the accountancy profession. She appreciated members for their support in the last two years she served as the Chairman of the Institute. She wished the incoming Chairman and Council the best of luck and asked them to actualize their campaign pledges.

FCPA George Mokua thanked members for electing him, and for their support and trust in him. He congratulated the new Council members, and pledged to work together with the Council, members of the Institute and other stakeholders to improve the accountancy profession. He assured members that he would review and action the campaign pledges of all candidates, and the pending work which was handed over to him by the outgoing Chairman.

It was reported that CPA Andrew Bulemi, (M/No. No. 7732) had written to the Institute requesting for the following to be added as a matter to be discussed under 'any other business' at the meeting.

'I would like to raise a motion that members to allow and pass that the election process of the Institute be conducted independently and away from the control of the Institute and Secretariat. My proposal being IEBC.'

The Chairman informed members that the matter would be referred to a Committee for deliberation, and thereafter members informed of the way forward at a general meeting.
