SUSTAINABILITY REPORTING ROADMAP



Formation of a Multi Stakeholder Committee on Sustainability Reporting to guide on the roadmap for implementation of IFRS Sustainability Standards adoption across different sectors.









In response to the demand for improved global consistency & comparability of sustainability reporting, the International Sustainability Standards Board (ISSB) issued its first two standards on 26 June 2023

IFRS S1 outlines general requirements for disclosing material information on sustainability-related financial risks and opportunities, while IFRS S2 focuses specifically on climate-related disclosures.

ICPAK adopted the new standards on 6th September 2023 & subsequently launched the National Roadmap for Adoption of Sustainability Related Disclosures on 14th November 2024.

The phased adoption of IFRS Sustainability Disclosure Standards in Kenya aims to transform the corporate reporting landscape, fostering a more sustainable business environment.

SUSTAINABILITY REPORTING ROADMAP...CONTD



Phase 1



Voluntary Adopters, 2024-2026

- Organizations can voluntarily adopt the standards, focusing on capacity building and readiness for mandatory compliance.
- Entities will undergo a readiness assessment before reporting.

Phase 2



Phase 3

Mandatory Adoption

- Public Interest Entities: Required to comply from the accounting period beginning 1 January 2027.
- •Non-PIEs (Large Enterprises): Compliance begins from 1 January 2028.
- •Non-PIEs (SMEs): Compliance begins from 1 January 2029.
- •Readiness assessments will be mandatory before the initial sustainability report is published.

Governments and Government Organizations

• Implementation will be aligned with sustainability reporting standards for the public sector currently being developed by the International Public Sector Accounting Standards Board.

FiRe Award 2024



FiRe Award is Kenya's premier platform for recognizing excellence in financial reporting, corporate governance, & sustainability disclosures.



The FiRe Award 2024 attracted 1,132 entities across the public and private sector.



The award has 26 unique categories for both public and private sector entities.



This year's award was themed around "Championing for effective sustainability reporting through technology and innovation to enhance transparency".



A new category on ESG Reporting-GRI was introduced as we transition into a sustainability-oriented future







IPSAS Accrual- ICPAK Role and forward-looking assignments













Implementation of accrual accounting in the public sector is a significant priority across many jurisdictions.

According to the International Public Sector Financial Accountability Index, in 2020 only 30% of governments in the 165 iurisdictions included in the Index reported on an accruals basis, but this is projected to increase to 50% by 2025 and 73% by 2030.

In Kenya, as all government organisation's that were previously reporting on IPSAS cash transition into IPSAS Accrual for the period starting 1 July 2024

ICPAK in collaboration with the National Treasury & other players will play a key role in ensuring a seamless transition over the next 3 years.

ICPAK is represented in the various technical working groups as well as the Executive Committee driving the transition efforts.

REGULATION: IMPACT OF GREY-LISTING OF KENYA TO ACCOUNTANTS



The grey-listing of Kenya brings critical responsibilities for accountants, whether they are sole practitioners, partners, or employees in professional firms. Key actions include the following:-

Accountants must register with the Financial Reporting Centre (FRC) to comply with new regulations. Conducting thorough assessments of Money Laundering (ML), Terrorist Financing (TF), and Proliferation Financing (PF) risks related to clients and services is essential.

Implementing robust Anti-Money Laundering (AML), Counter Financing of Terrorism (CFT), and Counter Proliferation Financing (CPF) policies, along with internal controls, is vital for operational integrity.

Accountants must adhere to the Proceeds of Crime and Anti-Money Laundering Act (POCAMLA), the Prevention of Terrorism Act (POTA), and related regulations.

Enhancing staff knowledge of AML/CFT/CPF measures through training is crucial for compliance.

Immediate action on Targeted Financial Sanctions (TFS) related to TF and PF is required.

Maintaining accurate records of clients' beneficial ownership information is essential for transparency
